THE ONWARD MARCH TOWARDS POVERTY ALLEVIATION

Buddha Institute has partnered with Selco Foundation for solarizing processing units of Buddha Fellows B. Srinivas and Satendra Lilhare on millets and Non-Timber Forest Produce (NTFP) in A.P. and Chhattisgarh respectively.

Under partnership with Rajeevika, the Government of Rajasthan, Buddha Fellows Rakesh Gupta and Rajesh Oza are helping tribal women establish NTFP processing units in Rajsamand and building their capacity to run such units themselves. 55 tribal women have undergone exposure visits to the NTFP processing unit in Udaipur. Women leaders of Karauli's Cluster Level Federation have visited Buddha Fellow Satyam Bhandari's cold pressed mustard oil unit in Hindaun City. Now, more and more women are coming forward to participate in business development activities and not just become receivers of some charity.




PROGRESS ON THE NEW RECRUITMENT OF 2023-25 COHORT


